



## Message From the Board

**Everyone has a Larc story** – a story about something or someone who has brought Larc into their lives. The stories are of challenges and triumphs, love and loss, courage and resilience. Here is my story.

I first met Ed McDonnell through my husband, Frank Spencer. Frank was a Camden County Freeholder from 1994 to 2000. In the political world there are plenty of campaign events I attended with Frank, and Ed was there. We were introduced and I liked him immediately, especially his wit!

In 1997, the McDonnell and Spencer families were facing tragedies—Ed's brother, Tom, 50 years old, was seriously ill with cancer, Frank's brother, John, 32 years old, was seriously ill with cancer, and my father, Tom O'Malley, age 69, was seriously ill with cancer. Tom McDonnell passed away in October 1997; Tom O'Malley in November 1997; and John in December 1997.

Ed visited Frank and me at our home shortly after John died. I can remember the three of us sitting at the dining room table just feeling so numb, sad, and exhausted. We talked and talked about our deceased family members and how they suffered. It

was all very emotional. Then Ed said, "Let's talk about something happy!" And that was the beginning of my involvement with Larc!

We talked about our kids—my son, Sean, was in 4th grade at the time; Ed's daughter, Kate, was in her junior year of high school; and his daughter, Mandy, was at Larc. It was a great conversation, just bragging about them in a fun, positive way. I learned what Larc was all about. We talked about the golf tournament fund raiser that Larc has every year. Frank then started playing in the golf tournament and I would join him at the dinner. I got to see the same faces year after year and then I began to actually play in the golf tournament, too.

We were invited to the Appreciation Breakfast and that was the first time I was given a tour of Larc School. What struck me the most as Susan and I walked the halls and peered into the classrooms were the smiles on the faces of the children. You could just tell that they were so happy to be there. I remember watching the staff being so kind, loving, and helpful. And I remember there was a little boy being pushed in a wheel chair who stopped to tell Susan about something he did. He looked so proud! Susan smiled and congratulated him. Then Susan told me about the progress this little boy has made at Larc. I remember that after the tour I couldn't talk—I was just so moved I was speechless. It was shortly after that tour that Ed told me he wanted to expand the Board and asked me if I would be interested in serving.

Because our tragedies brought us together at my dining room table, I am here at Larc. I'm honored and proud to serve, and I thank you, Ed, for choosing me and giving me my story.

He passed away on August 17, 2011, and we want to keep the tradition going in his memory. There isn't a day that goes by that we don't think about him. He was larger than life and always brought a smile to your face. Christmas was his favorite time of the year.

For us, the Larc visit embodies the spirit of Christmas. We love going to Larc and working with the children. And the kids give so much back to us. You see how hard they work and how hard the staff works.

Everyone at Larc greets you with a smile. This doesn't happen everywhere. It's a very welcoming environment. It is always a very fulfilling experience.

### Technology Opens New Worlds For Larc Kids

Many of us use technology

everyday — we check our email or the weather on our computers, iPads and tablets. We shoot a quick text message to a friend or loved one on our smart phone. It is hard to remember how we got along without all that technology.

For Angelina P., a thirteen-year-old at Larc School, it's hard to remember not being able to "talk"—even though she is non-verbal. Angelina talks through technology. She uses a speech generating device (SGD), also known as a *talker*. Talkers are computerized devices that often use picturesicons—to represent words. A student can touch the icons to create words and phrases, which are then "spoken" out loud electronically by the computer. Talkers can give students like Angelina a voice. In fact, they can give students more than a voice—it can open up a whole new world.

Angelina doesn't remember, but when she first came to Larc School as a pre-schooler, she didn't have a talker. She would not stand, walk, wear her glasses or feed herself at school. It wasn't because she couldn't. It was because she was frustrated. Angelina does all those things and more now that she is free to express herself both her likes and dislikes.

"Angelina is so smart," said Kelly Adams, Angelina's one-on-one assistant and a Occupational Therapy

### Long Live The Bake!

An interesting fact about lobsters: they continue to grow as long as they live.

This amazing ability might serve as a metaphor for the relationship between Larc School, the **Young Lawyer Committee (YLC) of the Camden County Bar Association**, and the yearly **Lobster Bake** event benefitting Larc School, presented by the YLC each year since 2010.

"Every year, we bring a few more Young Lawyer members to Larc School. After visiting Larc, they become very involved with the Lobster Bake," said **Rachael Brekke, an attorney with the New Jersey State Board of Public Utilities**. "And once our attorneys become connected to Larc, they want to bring their colleagues."

A Camden County Bar Association-Young Lawyer Trustee and chairperson of the 2013 Lobster event, Ms. Brekke said the YLC would like to see the event open to other bar association members, bringing more attorneys to see Larc School. "Meeting the children and going into the classrooms with them, you can feel the impact of your efforts," she said.

Since the first Lobster Bake in 2010, the event has grown each year. About 200 guests enjoyed a sumptuous lobster dinner at **The Tap Room**, in Westmont, this past September, culminating in a contribution of \$18,585 to Larc School from the YLC. The gift is to be used for whatever project Larc chooses.

As the event grows, so does sponsorship. "Our success can be attributed to the efforts of Mike Dennin," said Ms. Brekke.

"The lobster bake is a way to give back to our community and those in need. It's our charitable highlight of the year," said **Michael Dennin, an attorney with the Law Offices of Vincent J. Ciecka, P.C., Camden County Bar Association Trustee, former Young Lawyer Trustee, and chairperson of the 2012 Lobster Bake**. "This past year we added a sponsorship level—the Claw sponsorship. We also gave out favors to guests—a shindig drinking glass displaying the names of sponsors."

student. "She blows my mind with the things she is able to say through her talker. Some students need to think about what to say and how to say it using their talkers, but Angelina is so fast with her device and knows how to say what she wants even when the icons for a specific word are not available to her."

One of Angelina's fellow students shares a similar experience. **Liesl R.** came to Larc School as a teenager. She was also nonverbal and had not used a talker at her previous schools.

"Thanks to her talker, Liesl has become a much more mature and social person," said Liesl's mother, Elizabeth Dalzell. "She can arrive home and talk about her day. She can ask for favorite foods, request activities, or express thoughts and happenings that made her happy or sad. When her grandfather passed away suddenly, the talker helped her express her thoughts of sadness, confusion, and anger."

"Everyone wants his or her child to fit in, and now mine does," Ms. Dalzell said. "Liesl now has the power to talk with her classmates, friends, and individuals in the community. The talker also allows her to tell people if they are bothering her. Instead of acting out in an inappropriate manner she can just press her annoy button. We should all be so lucky!"

### Having a communication device has allowed Liesl to truly be Liesl.

"Having a communication device has allowed Liesl to truly be Liesl," said Stacie Halscheid, who taught Liesl previously. "Liesl is much more comfortable in her own skin now that she has a way to let us know she has a lot to say. Because of this device, we have found out that this child has an extraordinary sense of humor and understands the world around her."

While talkers can provide an out-loud voice to students, other technologies can provide something less concrete, but no less valuable—motivation.

Larc student **Daymion J.** had a striking response to the Team Board, an interactive, touch-screeen teaching aid that allows Larc students to show what they know and learn by touch. Acquired in 2008, the 77-inch, interactive whiteboard can be found in the library and a mobile, adjustable Team Board is used in the classrooms. With its lights, colors, and interactive features, the Team Board is an enticing device, as evidenced by its effect on Daymion.

"When I first met Daymion, he could not walk or stand on his own," said Gina Gambone, Daymion's first teacher at Larc School. "Throughout the year, I looked for motivators for Daymion and found he was very motivated by the Team Board."

Daymion would stand in front of the Team Board while holding a staff member's hand. After a while, he used the Team Board as a support. "Then one day, while I was holding his hand across the room, he let go and took off toward the Team Board. He was so proud of himself," said Ms. Gambone. "Each week, we moved his chair further away from the Team Board, and each week he succeeded in walking that distance!"

Rachel Saunders, Daymion's mom, credits Larc School Staff with his tremendous progress. "When Daymion started at Larc, he had issues. He wasn't walking and he wouldn't let me touch him, brush his teeth or hair. But Larc Staff got him to touch everything. They worked with him and would not give up," she said.

"And when Gina introduced him to the Team Board, it motivated him enough to get up and walk," said Ms. Saunders. "Larc opened up a whole new world to Daymion. Now he's curious about everything!"

As with the talkers, Team Boards are expensive. Larc's Team Boards were realized through a grant from the Camden Home for Children & S.P.P.C. Purchase of the school's talkers and many other devices are funded in part by Larc's Annual Golf Tournament, Annual Run the Bridge Event, and other activities so generously supported by Larc Friends and Families.

The Larc Staff and Families are most grateful to Larc supporters for the opportunity to be able to secure these technological marvels and open new and wondrous worlds for the deserving students at Larc School.

The Heiser family is, in every sense of the word, a Larc Family. Twelve-year-old Jacob is a student at Larc. Jacob's twin sister, Abigail, who is in public school, attends the sibling program at Larc to help her and her brother Jacob enrich their relationship. Fifteen-year-old Noah is autistic and also attends public school, but enjoys the support of Larc staff during family and social functions at Larc. Jacob's oldest sister, Rachel, volunteers whenever her college course allow her the time. And Jacob's parents, Nicole and Don, are avid volunteers at Larc.

Larc School came into their lives when Jacob entered the school as a student nine years ago. "We chose Larc because of the friendly and family feel the school gave," said Nicole Heiser. "Larc is welcoming from the minute you walk in, and Jacob has been very comfortable there since the first day. Everyone at the school knows my whole family and we know everyone at Larc. They embrace my older son, too." Ms. Heiser said that Jacob, who is severely disabled and dependent on those around him for everything, has thrived at Larc. "Jacob is

blind and can't even hold his head up, but they didn't put him in a corner at Larc. The staff has always advocated for him," she said. "They introduced him to a speech-generating communication device when he was five or six, and he's progressed by leaps and bounds. He does extraordinarily well by communicating with a head switch."

Ms. Heiser, who is working toward a nursing degree at Rowan College at Gloucester County, said, "I'm very involved with Larc. I volunteer for the Run, stuffing tons of food bags and information packets for the runners, and working at the Run itself all day, starting at 5 A.M."

She also volunteers at Larc's annual golf tournament, Larc's Santa shop, and runs Larc's Yankee Candle fundraiser sale at Christmastime.

Don Heiser, a locksmith with Campbell Lock & Safe, in Westville, shows that he knows how to open his heart as well as doors by volunteering on Saturdays for the Larc Run. "He does a lot of the heavy lifting, moving boxes and such for the Run," said Ms. Heiser.

Nicole and Don Heiser continue to find time to volunteer for Larc for many of the same reasons other Larc friends and family members do.
