It's hard to believe how big this event has grown from its humble beginnings as a local 5K around Bellmawr with 200 participants back in 1996, to the sophisticated, major running event in the Tri-State area that it is now. The extraordinarily popular Cooper Norcross Run the Bridge closes the Benjamin Franklin Bridge to traffic, allowing thousands of participants and supporters to run over and back, and through the Camden Waterfront area in support of Larc's kids.

It doesn't happen overnight and it doesn't happen without an incredible team of dedicated people behind the scenes! Throughout the year, a committee of our friends and sponsors from Cooper University Health Care, The Norcross Foundation, AmeriHealth New Jersey, Delaware River Port Authority, Camden County, and the Running Co. of Haddonfield meet once every couple of months to plan and prepare for this enormous undertaking. We also receive amazing support from Rutgers University, the Riversharks, Coopers Ferry, the Camden County Police Department, and many more. We are so grateful for their friendship, for believing in Larc School, and recognizing that our students and families truly need their support.

I have been blessed in many ways throughout my life, and one of them certainly has been my relationship with Larc School. When I was asked to be the Special Friend of Larc, I was overwhelmed and honored!

I first met Susan Weiner when I toured the school with her and Joe Morrissey in late 1996. I was not aware that Larc School even existed until that day. At the time, I was an employee of Commerce National Insurance and Joe asked me to be the account executive for Larc School's insurance portfolio. Touring the school, my heart melted when I heard the soft voices of caring teachers working with the children and saw the children's smiles—so happy and proud of what they did or said.

Not long after that, Susan and I met to discuss business and, of course, exchanged personal stories. I told Susan that, since 1979, my husband, Joe, and I have been hosting a golf tournament to fund a scholarship in memory of our son, Joe, who died in a car accident while a senior at Audubon High School.

I remember how our little town of Audubon rallied around us and how appreciative we all are to this day—my husband and I, our daughter Dawn, and our two grandsons, Matt and John. Our community, school administrators, and borough councilmen were right there to offer support and ideas on how to fund the scholarship that my husband wanted to start. They have continued their support and help all these past 37 years. We chose

a golf tournament to fund the scholarship as my son was on the golf team, and I'm proud to say he was an exceptionally good golfer at only 17 years of age.

My heart melted when I heard the soft voices of caring teachers working with the children and saw the children's smiles—so happy and proud of what they did or said.

When Susan heard my story, she was quick to ask me to join Larc's golf committee and I was happy to do so. When I grew up in the early 50s, my mom was a single parent of four and she taught us that you don't need money to help people ... always be kind ... there are many things that you can do to be helpful—open a door, carry a grocery bag, cut someone's grass. I guess some of that rubbed off on me. I love doing things that I know will be helping Larc's kids.

I'm always amazed at all Larc does for and with the children. The children are always first in the minds of the staff. They are always asking, "What can we do for our children?" The parents of these very special children have a wonderful, safe, happy school for them. The fact that the parents do not have to provide anything for their child's care is simply amazing. While my heart breaks for the children and their parents, I am so happy they found Larc School. The love that Susan, her staff, board members, and friends of Larc have for the students is endless!

The work they do is carried out with so much love, kindness, and patience. You can see and feel the love and compassion from the entire staff whenever you are in the school. To see the smiles on the children's faces as they are getting off the bus, going up and down the halls, or are in their classrooms is proof to me that they are happy at Larc.

Although my professional/business relationship with Larc lasted just three years, my personal relationship with the school continues, and that's what is most meaningful to me. It's a relationship I truly treasure. I will continue to be involved and help in any way I can for as long as I'm physically able to do so.

Thank you, Joe Morrissey, for introducing me to Larc. Thank you, Susan, for asking me to get involved on the golf committee. Saying yes was one of the best decisions I have made in my life! Thank you, Larc Staff, for all you do for the children!

# The Kruger Family: First Year At Golf, First Year At Larc

When it was time to send their four-year-old son, Ryan, to pre-school, the Krugers thought it was going to be difficult finding the right place for him, as he has spastic quadriplegic cerebral palsy. But Mom Jennifer Kruger explained, "We found Larc after a couple of school tours with the Mt. Laurel Child Study Team and immediately fell in love with it."

Dad Ben Kruger agreed. "Everything about the school works for Ryan's needs—the size of the classrooms, the number of the staff working with the kids, the right amount of structure, and the school itself," said Ben. "It all seems to work for him."

"And Ryan loves it," said Jen, who particularly loves the communication with Ryan's teacher. "It's exceptional," agreed Ben. "There's constant communication. A book comes home daily with Ryan telling what he did, and we send back what he did at home."

The Krugers are thrilled with the progress their son has made since he started Larc last fall. "It's a life changing experience for him and for us," said Jen. "He's so excited to go, and we've seen so much improvement since he's been at Larc. The staff knows how to get him to eat and drink ... probably better than at home!" Ben agreed, "And Larc's Speech Therapists are helping to secure a speech device for Ryan so he'll be able to communication with us. We are very excited about that. Every day is something different, something good."

Giving back is very important to the Krugers, who both work at TD Bank. Jen was involved with the Yankee Candle fundraiser and with the Secret Santa Workshop last Christmas. "Currently, I'm doing a fundraiser for the Run. I reached out to a tee-shirt

to know that Ryan is loved. The teachers, the principal are all so welcoming. You just don't feel different here.

company and got 117 orders so far for Ryan's team—that's \$600 for Larc!" she shared.

Ben joined the Golf Committee earlier this year. "I enjoyed being in the tournament and on the committee working with other parents. I put together a couple of foursomes, including coworkers and family members. It was a fantastic event. Everyone I invited had a great time," Ben said. "I've been very impressed with this event. Larc has been organizing the golf tournament for many years and they have it down. I see a lot of outings in my line of business, and I can tell you this event is well organized. I look forward to being a part of many more in the future—on the committee and at the event.

"One thing we particularly like about Larc is how comfortable it is," he said. "From the executive director to the secretary, everyone seems so very welcoming. You can have a casual conversation with anyone. It's a great thing to be able to trust. It's wonderful to be comfortable when we leave him and know he's safe. We trust who he's with. It gives us peace for the days he's at school, allowing Jen and I to work. We know he's under good care and enjoying himself."

"It's so nice to feel part of a family that can understand what we're going through," said Jen. "It's so good to feel accepted, and to know that Ryan is loved. The teachers, the principal are all so welcoming. You just don't feel different here."

### Giving Technology a Hand

Larc's New Assistive Technology Position

Assistive Technology is not new, but Larc's Assistive Technology position is! Assistive Technology (AT) is just what it sounds like—using technology to assist people with disabilities in performing tasks that otherwise would be difficult or impossible to accomplish. It could be as high-tech as an adaptive head switch or as low-tech as a foam tube properly placed to help with positioning.

"Through the years, both the technology needs and opportunities for our students have exploded. We have devices and equipment today that we just didn't have 20 years ago," said Larc Executive Director Susan Weiner. "With these new technologies come new challenges. A smart board is great for a student who can stand and touch the screen, but how do you make that technology available to a student in a wheelchair who has difficulty extending his or her arm?"

At Larc School, you call on their Assistive Technology Assistant. The role of this new position is to analyze the technology needs of Larc students, work collaboratively with teachers and therapists to find solutions to problems, and create alternatives designed to enhance communication, mobility, positioning, and access to technology and education.

Little did Larc know that their first ever AT Assistant was already in the building. As a classroom assistant at Larc School for several years, Lydia Jenchura learned first-hand the unique challenges Larc's students and teachers face. After hearing about the AT Certification program from a friend, Lydia pursued the program on her own. Larc Principal Bethann Rogers first learned of Lydia's interest in AT when she found her studying during her lunch break.

"We understood the value of Lydia's AT endeavor," said Mrs. Rogers, "so we started to develop an Assistive Technology position at Larc. Originally our goal was to open this position for one year, but it's been hugely successful, and now we can't imagine not having it."

"I love the position," said Ms. Jenchura. "I feel I'm helping many students have a more productive and fulfilling environment. It's very rewarding."

In addition to finding solutions to students' needs on a daily basis, Ms. Jenchura continually researches new technology that might be of help to Larc students. Her newest find is TAPit. This interactive, desk-like learning station is designed to work with a computer and has the remarkable ability to recognize the difference between an arm resting on a screen and a finger intentionally tapping the screen.


"The TAPit is expensive, but our children with limited physical ability will greatly benefit from it," said Mrs. Rogers. Larc is now the proud owner of a TAPit, thanks to a grant from the Camden Home For Children And S.P.C.C., and a gift from Mark Pellegrino and family, and the Pellegrino Automotive Group. Many, many thanks from AT Assistant Lydia Jenchura, the rest of the Larc Staff, and, of course, from the many Larc Kids who will benefit greatly from this unique technology!
