Larc and Camden County College Partner to Improve Dental Hygiene for Individuals with Disabilities

Larc School and Camden County College (CCC) team up for the second year to provide educational opportunities for both Larc students and adults as well as the students in the CCC Dental Hygiene and Assisting Programs. Last March, CCC students visited Larc School to perform dental wellness screenings and to gain valuable experience on how to best serve individuals with special needs. Larc administrators welcomed the CCC students and shared information about the severity and variety of disabilities they would see during their visit. They shared suggestions and best practices on how to communicate, position, and overcome obstacles Larc students and adults face when visiting the dentist. Larc's individuals practiced communicating, sitting still, and listening to directions during their screening. Larc families were happy to have their children benefit from having a dental wellness check during their school day!

This March Larc is excited to continue its relationship with the CCC Dental Hygiene and Assisting Programs by having Larc staff take part in the first of a series of virtual panels with CCC students. Larc staff will share their expertise and answer questions about interacting with and providing services to individuals with special needs. Later in the spring, CCC students will give a virtual lesson to students and individuals on dental hygiene and nutrition.

Larc is grateful for this opportunity to partner with CCC and would like to acknowledge the Area VII Physicians who provided a generous grant to make this partnership possible.

For secondary graduates that were able to attend, it was bittersweet—a final goodbye to a school that will always be like a second home. Teachers gave their students an emotional send off with a tribute that included pictures of grads through the years and a heartfelt speech highlighting special memories and accomplishments.

Larc School closed our doors on March 17, 2020 in response to the Covid-19 health crisis and moved to a Remote Learning Plan. During the uncertainty of the first few months, our confidence in the incredible creativity and expertise of our staff and in the strength and resiliency of our students and their families carried us. In the remote learning environment, we continued to focus on providing our families with the high level of programming and individualized support they were accustomed to receiving.

This shift also required a high level of adaptability and that is something Larc knows all about. Larc teachers, therapists, and staff are experts at adapting. It's what they do every day. They find new ways to help our students reach their goals. Teachers and therapists reached out to each and every family and made sure they had everything they needed to support their child in this new environment. Families became co-teachers and co-therapists.

The next challenge was in finding the resources to meet everyone's technology needs and as the situation unfolded, the resources to get the safety and personal protective equipment needed to get back to school safely. Again our Larc Family came through, but this time it was our friends and our sponsors through their generous donations and grants that made it possible for us to meet this new challenge. Cooper University Hospital donated 500 cloth masks. Eagletree Capital donated 10,000 surgical masks. The Lauren Higgins Hope Award purchased 20 Chromebooks to be distributed to students in need. Target Community Engagement Funds and Eagletree Capital gifted Larc with grants to be used for Covid-19 preparations.

With all the incredible support we received, Larc was able to re-open its doors in September offering two tracks for students, full-time in-person and full-time remote. We moved to a fully remote track for everyone through the holidays and into the New Year. As this newsletter goes to print, our in-person students will be returning to the building on March 1st. Everyone is looking forward to the time when ALL of our students and adults can return to the building.

2020 has proven that the African proverb "it takes a village" couldn't be truer. And Larc School is so incredibly grateful for our village, for our family. It is that overwhelming sense of gratitude that we will take with us as we move forward into this New Year.


